When they are healthy enough then we find them new forever homes. In addition, we hold mobile adoptions at different sites, fairs, and festivals.

Veterinary Clinic: takes care of medical/surgical needs at the shelter, does all of our spays and neuters, and is open to the public to provide low-cost animal care. This benefits our community.

Outreach program: MaxFund administers a community-wide, and state-wide spay/neuter program for low-income pet owners, traveling the State of Colorado to rural areas to administer spay/neuter, vaccinations, and other minor services at no charge to people who cannot afford services.
